**Subject: Submission of Online Scholarship applications (Fresh/Renewal) under (AICTE) "Pragati Scholarship Scheme for girls students (Technical degree/Diploma) for the year 2025-26.**

Online applications are invited from the students eligible for above mentioned Scheme (AICTE Scheme) pursuing their, UG, and Diploma Courses in the University. The Scheme being implemented by AICTE aimed at providing assistance for advancement of Girls pursuing technical education. Education is one of the most important means of empowering women with the knowledge, skill and self-confidence necessary to participate fully in the development process. This is an attempt to give young women the opportunity to further her education and prepare for a successful future by "Empowering Women through Technical Education". The grant of scholarship is subject to the condition that student does not receive any financial assistance in shape of scholarship/any emoluments, salary, stipend etc. from any other source during her course of study in the Institute. In case of receipt of any financial assistance from any other sources, the scholarship shall be discontinued and the entire amount of scholarship will have to be refunded to AICTE by D/Draft drawn in favour of "Member Secretary, AICTE" payable at New Delhi and Strict action shall be taken against the student for furnishing any type of wrong/misleading information in respect of her eligibility and other details for getting the scholarship and for furnishing wrong/misleading information during the period of scholarship.

<https://scholarships.gov.in/> Only Online applications under these Schemes will be accepted and no request for offline applications will be entertained. The details / eligibilities of the Scheme are mentioned below:

### ELIGIBILITY FOR SCHOLARSHIP:

1. The girl candidate should be admitted to First year of Degree level course OR Second year of Degree level course through lateral entry in any of the AICTE approved Institution of respective year.
2. Maximum two girl child per family are eligible.
3. Family income from all sources should not be more than Rs. 8 lakh per annum during the current financial year. A valid income certificate issued by State / UT Govt. need to be enclosed.
4. Student Photograph.
5. Online application form authenticated from concerned Dean/Head of the Department.
6. Fee Receipt in original authenticated from concerned Head of the Department.


