Submission of Online Scholarship applications (Fresh/Renewal) under (AICTE) - Swanath Scholarship Scheme for Orphan Students (Technical Degree / Diploma) for the Academic year 2025-26

It is for the information of orphans, students pursuing their Under-graduate (UG) & Diploma programmes in the University, that Fresh / Renewal online applications are invited for Academic year 2025-26 through National Scholarship Portal (NSP) at www.scholarships.gov.in under Aicte - Swanath Scholarship Scheme for orphans, Student (Technical Degree / Diploma).

The Scheme is being implemented by AICTE to provide encouragement and support to orphans, wards of parents died due to Covid-19, wards of Armed Forces and Central Paramilitary Forces martyred in action (Shaheed) to pursue education. This is an attempt to give every such child, an opportunity to study further and prepare for a successful future through education in AICTE Approved institutions and courses.

The grant of scholarship is subject to the condition that student does not receive any financial assistance in shape of scholarship/any emoluments, salary, stipend etc. from any other source during her course of study in the Institute. In case of receipt of any financial assistance from any other sources, the scholarship shall be discontinued and the entire amount of scholarship will have to be refunded to AICTE by D/Draft drawn in favour of "Member Secretary, AICTE" payable at New Delhi and Strict action shall be taken against the student for furnishing any type of wrong/misleading information in respect of her eligibility and other details for getting the scholarship and for furnishing wrong/misleading information during the period of scholarship.

## **Eligibility for Scholarship:**

The candidate should be from any one of the following categories:

Orphan OR (i)

Either or both parents died due to Covid 19 OR

Wards of Armed Forces and Central Paramilitary Forces martyred in action (ii) (iii) (Shaheed)

Parent is suffering from critical life threatening disease (Like Cancer etc.) (iv)

Died or severely disabled (above 80%) in accident (as per RPwD Act 2016)

2. Family income from all sources should not be more than Rs. 8 lakh per annum during the financial year 2025-26. A valid income certificate issued by State/UT Government is to be enclosed.

3. The candidate should be currently studying in the AICTE Approved institutions and courses at Degree/ Diploma level in regular mode (in 1st /2nd / 3rd /4th year).

The candidate should NOT be Recipient of any of the Central Govt. / State Govt. / AICTE Sponsored scholarships.

Online application form duly authenticated from concerned Deans / Directors / Principals / Heads of the Department.

- 6. Student Photograph.
- 7. Fee Receipt in original authenticated from concerned Head of the Department.
- 8. Fee Structure / Bonafide (indicating annual course fee) in original authenticated from concerned Head of the Department.
- 9. Domicile / Permanent Residence Certificate.
- 10. Caste Certificate (if any).
- 11. Attached Pervious Qualification mark sheets except current session (Promotion Certificate)
- 12. Aadhaar Number with Xerox copy of Aadhaar card and seeding of Aadhar with bank. Proof of Bank account attested from concerned Branch Manager in the name of student.
- 13. A duly signed declaration by parents for Pragati Scheme which states that the information provided by my ward is correct. (on plain paper)
- 14. Affidavit duly attested by the notary to be attached. The specimen of the affidavit is as under:
