**NOTIFICATION**

On the recommendation of Committee constituted vide Office Memo no. BGSBU / DAA / 21 / 1381 dated 08-12-2021, the Hon'ble Vice Chancellor has been pleased to approve the following:

1. In order to ease the economic burden and to promote educational urge, the children of all the regular Class – IV employees of Baba Ghulam Shah Badshah University will now be given concession in the tuition fee @ 50% up to two children admitted in any academic programme in BGSBU. However, this incentive will continue only if their wards clear all the papers in one go in the semester / year of the examination.
2. To mitigate the financial burden, a monthly financial assistance of Rupees one thousand only (Rs. 1000/-) in the form of scholarship will be given to the two eldest wards of the deceased employee of the University which shall continue till their schooling up to 12<sup>th</sup> standard.
3. To incentivize and increase the enrolment of the girl students in higher education, University has decided to give a waiver of 50% in the tuition fee to the top two rank holder girl students based on the admission merit list in all post graduate programmes from the forthcoming academic session.

The above announcements shall be made by the Hon'ble Vice Chancellor on the upcoming occasion of 18<sup>th</sup> Foundation Day to be celebrated on December 15<sup>th</sup>, 2021.
