It was informed that for optimum utilization of resources and to provide opportunity to students as well as to in-service candidates to improve their qualification, the Vice Chancellor approved introduction of B.E. (Evening) programme in Civil Engineering and Electrical Engineering w.e.f. academic session 2016-17.

The members discussed the matter threadbare including details regarding, student intake, reservation of seats, fee structure, admission process, students admitted, Admission Committees etc and unanimously resolved to confirm the action taken in the interest of the University.

The members were further informed that the University is in the process of getting the academic programmes approved by the AICTE. The syllabi for B.Tech. (regular) programme having completed its statutory life, which is the same as for B.E. (Evening) programme is in the process of being revised, and shall be adopted as and when it is approved by the Board of Studies. The matter shall be reported in the next meeting of the Academic Council. Till such time the new syllabi are notified, the existing approved syllabi shall continue. The members deliberated the matter and unanimously authorized the Vice Chancellor to adopt the new syllabi, on behalf of the Academic Council, as and when it is framed by the statutory bodies.

*Hence, the following was unanimously resolved:*

1. *Confirmed the action taken in having introduced B.E. (Evening) programme in Civil Engineering w.e.f. academic session 2016-17 and approved the student intake, reservation of seats, fee structure, admission process, students admitted, Admission Committee as per the details given in Annexure 19 of the agenda of this Academic Council.*
2. *That Dean/Principal School of Engineering & Technology shall ensure that the programmes are approved by AICTE before the commencement of the next academic session 2018-19.*
3. *That the existing syllabi of B. Tech. programmes in different disciplines, which have completed statutory life, be continued for one more year academic session i.e. 2017-18 and the same be adopted for B. E. (Evening) programme also. The Vice Chancellor has been authorized to approve the revised syllabi for the B. Tech. / B.E. programme as and when it is framed by the statutory bodies.*
