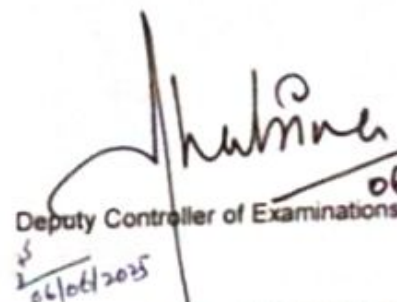
i) The candidates who have got backlog(s) in Semester - VI shall submit their Examination Forms within 20 days of declaration of the result.
