

- i) The students who got backlog(s) in Semester - VI shall submit their Examination Form duly signed by the concerned Head of the Department within 20 days of notification of the result without late fee. Thereafter, prescribed late fee shall be charged.
 - ii) For Re-checking and Re-evaluation; prescribed application form, duly attested by a University teacher/officer, accompanied by original Marks Card issued to the candidate and requisite fee of Rs. 300/- per script or the amount as may be notified by the University from time to time, should reach the Controller of Examinations within 15 days of the declaration of the result of the main examination concerned. Thereafter, no application form shall be entertained even with late fee.
 - iii) Re-evaluation of Answer Scripts shall be permissible in not more than 25% of theory papers in which a candidate has appeared in the main examination only.
